Dear Friends,

We want to thank you for your trust and support. The best way to show our gratitude is to let those who are on the receiving end of your generosity speak for themselves. This Donor Report **demonstrates the impact of your philanthropic gestures on the lives of those who benefit from them.**

The year 2019 was a turning point toward global awareness and openness to complexity. But for our University and for individuals like you, who share our values and objectives, sustainability, ethics and social responsibility have always been challenges to meet and for which to find answers and solutions.

Bocconi has grown in 2019—in international standings, ranking fourth in Europe and sixteenth in the world in both Social Sciences and Management, which itself is ranked third globally; in the excellence of its research, recognized by the number of ERC grants awarded; in the city fabric, inaugurating the New Campus built on the former Centrale del Latte site; and in its relationship with the job market, with a 95.2% employment rate one year after graduation.

Moreover, Bocconi has grown in its fundraising activity: thanks to the contributions of more than 1,300 donors who believed in our University and our initiatives, more than €12 million was raised in this exceptional year. These funds generated new opportunities for deserving students, with more than 120 need- and merit-based scholarships supported by donors. They have contributed to the dissemination of knowledge, with 4 new chairs and 2 endowed laboratories. They have also supported the construction of a lively and stimulating environment, with the promotion of sports activities and annual events and the naming of 6 new spaces.

In light of the public health emergency we are experiencing, we are aware that the year ahead will be full of challenges. However, with you by our side, we are confident that we can **actively contribute to the recovery and construction of a new future for the country and for society as a whole. Together we can go beyond. Beyond what is within our reach.**

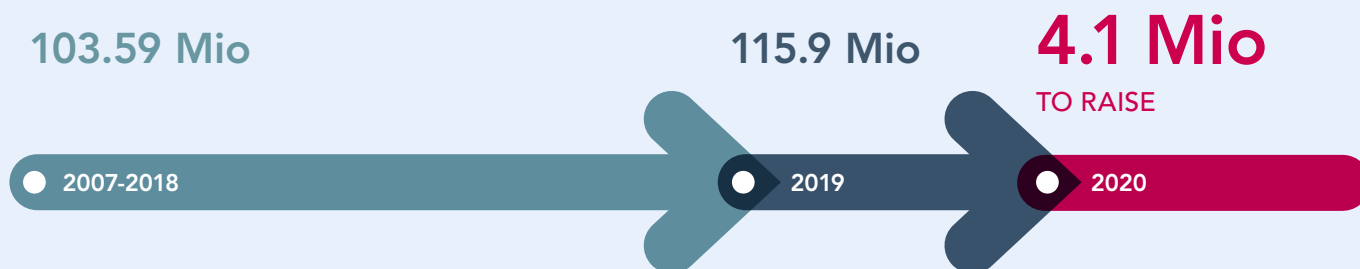

Amount in euros

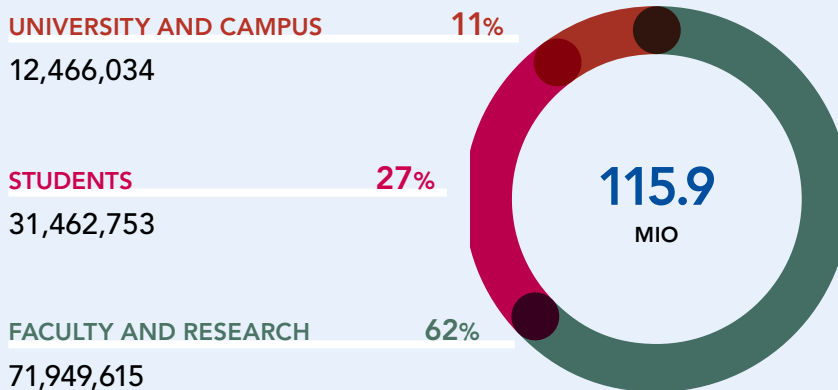
01/01-31/12

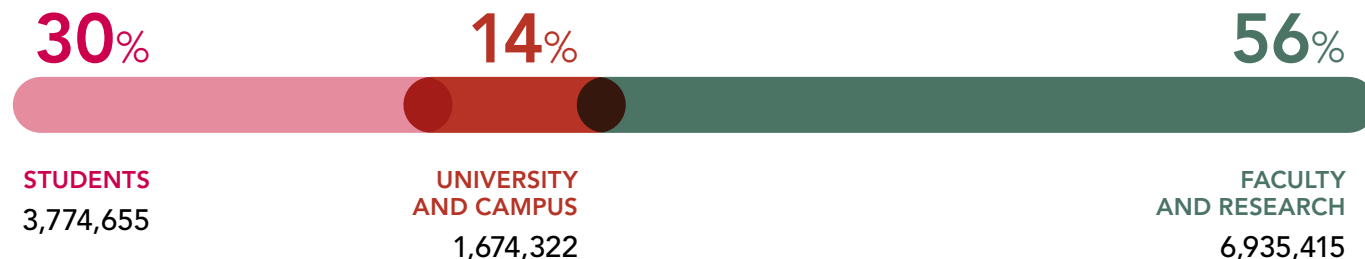

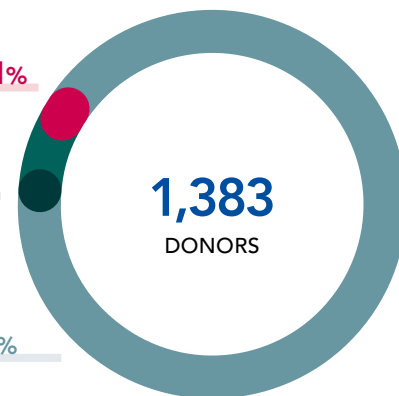

FROM BENEFICIARY TO SUPPORTER OF ALBANIAN STUDENTS

The story of Erdit Hoxha (Finance, 2005) is emblematic. Of Albanian origin, after a year of study at the Hong Kong University of Science and Technology he enrolled at CLEFIN Bocconi.

These years of intense commitment and sacrifice earned him a brilliant career in London, at Goldman Sachs, of which Erdit is now partner and Head of European Equity Trading. Just a few months ago, he promoted significant investments in the field of artificial intelligence, with the aim of evaluating a wider adoption of it in equity trading for the creation of new markets.

Very connected with his country of origin and the human and professional growth of young Albanians, Erdit makes

himself available to offer his personal experience and to support new generations in both London, where he lives and works, and at his Alma Mater.

A recipient of a Bocconi scholarship himself, Erdit is well aware of how important it can be for young students to be able to concentrate on studying at a prestigious university without worrying about an excessive burden on their families.

This is another reason why Erdit chose to invest in future Bocconi generations. In 2019, the first three beneficiaries of his support were selected through the "Una Scelta Possibile" program, created in 2013 to promote social mobility. ■

PLACING PEOPLE, NOT LOGARITHMS, AT THE CENTER

Paolo Basilico (Business Administration, 1984), former Chairman and founder of the Kairos Group and a leader in savings management and private banking, has always believed in the strength of young people as the lifeblood of growth and development.

In 2005, he established the Fondazione Oliver Twist Onlus, a non-profit organization committed to helping children, young people and young adults who live in Italy in situations of hardship and social disadvantage. Throughout his career he has often met with students to stimulate their motivation and enthusiasm by sharing success stories from various professions and spheres of life.

It is people, and not logarithms, at the center of finance, Paolo points out in his recently published autobiography, *Men and Money*, in which he discusses his experience in the world of finance and the secrets to investing successfully.

Since graduating from Bocconi Paolo has maintained a strong bond with the University. In 2019, he offered his support to Ludovica Solla, an International Management student, with a Partial Graduate Scholarship. ●

Friulian manager Claudio Zampa and his wife Simona Garelli are Bocconi graduates in Business Administration, now living in Switzerland. However, they have not forgotten the University that brought them together and into their brilliant careers in finance, and, for Simona, also in the arts. Through their foundation, they decided to make a significant commitment to support six students in the "Una Scelta Possibile" program and nine students in the Partial Graduate Scholarship program.

Giving priority to young people from Friuli Venezia Giulia, as indicated by Claudio and Simona, the first five students were identified based on merit. They will now be able to undertake their education with more peace of mind. Generali Italia INVESTING IN ACADEMIC TRAINING AND FEMALE TALENT

Clara Marioni is the beneficiary of the “Generali 4 Girls in STEM” Partial Graduate Scholarship for 2018/2019. The scholarship was created in 2018 under the common impetus of Generali Italia and Bocconi to encourage and support an increasing number of talented women in degree courses in the scientific, technological, engineering and mathematical fields. Clara is enrolled in the Data Science and Business Analytics degree course, which teaches brilliant young minds the most advanced techniques to extrapolate from complex datasets the information most useful for guiding the decision-making processes of the organizations in which they will work.

Investing in the academic training of the new generation guarantees added value for the future, for the benefit of both civil society and the world of work, as well as, of course, for the recipients’ professional growth. ■



Paolo and Esmeralda Merloni A SCHOLARSHIP FOR DESERVING STUDENTS



Paolo Merloni (Business Administration, 1992), the current Executive President of Ariston Thermo, has a strong connection with Bocconi, where he began his education. Here, he met the people who had the greatest impact on his private and professional lives. Many of his closest friends are from Bocconi, including his wife, Esmeralda Giuliani, who also has a degree in Business Administration; together they have three children.

Since 2017, Paolo and Esmeralda have provided merit-based opportunities for students, helping them overcome economic and gender disparities through their contributions, which have made the university experience of those deserving students free of financial strain.

In 2019, they offered support to a student with a scholarship in their name through the Bocconi Graduate Merit Award program. Andrea Elena Giacometti, in the International Management course, was the beneficiary of the award. ■

Roberto Bertazzoni ENCOURAGING MERIT AND GENDER EQUALITY

Bocconi has a historic Donor, Roberto Bertazzoni, who year after year has provided support for students through an increasing number of scholarships and grants distributed equally between male and female students.

From 2015 through to today, more than 50 young people have benefitted from his generosity, by virtue of a relationship of trust and sharing of values like gender equality and encouraging merit and social equity. In the first years of support, the scholarships were dedicated to the memory of the donor's parents.

Today, to maintain confidentiality, this donor asks that the University not communicate to its beneficiaries who the contribution comes from, but is willing to meet the students if they request it. In 2019, ten students were supported through Partial Undergraduate Scholarships and Graduate Bocconi Merit Awards (BMAs). ●



Equita SOCIAL MOBILITY AND GENDER EQUALITY IN THE FINANCIAL SECTOR



Education is one of the cardinal principles that characterizes Equita, and one of the key elements of the Group's Corporate Social Responsibility strategy. Our aim has always been to support young people. This year, with the renewal of the partnership with Bocconi for a four-year period, we wanted to facilitate the growth of women in the world of finance.

Equita has been a Bocconi partner for nearly a decade. Since 2016, in addition to supporting scientific research in the financial field, it has supported deserving students of the University. Equita believes in the value of people, considers them a real corporate asset and invests in young people's education. In line with these values, the four-year partnership with Bocconi, renewed this year, relaunches support for students and provides an effective contribution to social mobility through the enhancement of human capital from a gender equality perspective. In 2019, as a supporting partner of the University, Equita has chosen to finance two Partial Scholarships for the Executive MBA and two Bocconi Awards for Women in Finance, all intended for female students of merit. The first women awarded this recognition were Carla Costa, for the Master of Science in Finance, and Silvia Sartor, who attended the Modular EMBA, which started in November 2019. ●

Cyber Risk

AN INNOVATIVE PARTNERSHIP BETWEEN BOCCONI UNIVERSITY AND POLITECNICO DI MILANO

Cyber risk is a hot and extremely topical issue, perhaps still underestimated. Today, it is vital to protect companies' IT infrastructures and prevent economic and financial damage. To achieve this, a suitable, interdisciplinary professional education is required.

Hence, the Master of Science in Cyber Risk Strategy and Governance was created as an innovative partnership between Bocconi University and Politecnico di Milano, which unites the two universities' areas of excellence: high-level training in technology, combined with strategic and economic preparation. The course provides all the necessary

tools to understand, evaluate and govern the opportunities and threats related to existing and emerging technologies. This includes providing the skills necessary to guarantee regulatory compliance in terms of data protection and privacy, as strict European regulations require today. The Master's degree benefits from the valuable collaboration of six partner companies: Cisco, Intesa Sanpaolo, KPMG, NTT Data, Spike Reply and Vodafone. Each partner supports three Full Scholarships and contributes to teaching with case studies, testimonials and company visits. ●

Ceresio Investors – Foglia Family A STUDY GRANT FOR A DOUBLE DEGREE

The bond between the Foglia family and Bocconi is significant and long-lasting, allowing entire “generations” of Bocconi students to undertake and complete their education. Over the years, the Foglia family has supported various institutes and initiatives. Bocconi has recognized these with the recent endowment of a classroom in the Velodromo dedicated to Antonio Foglia (1891-1957), a Bocconi graduate, the first President of the Milan Stock Exchange after the World War II and the founder of what is now known as the Ceresio Investors Group. This year, the Foglia family established the “Ceresio Scholarship” in support of the Double Degree program in European and International Public Policy and Politics, created from the collaboration between the London School of Economics and Political Science (LSE) and Bocconi University.

The two-year program, with the first year in Milan and the second in London, allows students to obtain two degrees—Bocconi’s MSc in Politics and Policy Analysis and LSE’s MSc in European and International Public policy—not to mention the unique experience of attending and experiencing the atmosphere of two prestigious universities in an interdisciplinary and multicultural context. ■



The Ceresio Scholarship supports the double degree in European and International Public Policy and Politics and thus the bridge we hope to establish between Bocconi’s European and international vocation in Italy and the critical and globalized spirit of the LSE in the United Kingdom. As an alumna of both universities, I believe that this educational path offers personal and professional growth, along with the openness increasingly necessary in the current historical context.

PATHWAYS TO SUPPORT

► NAMED CHAIRS AND PROFESSORSHIPS

Establishing a named chair or professorship is one of the most prestigious ways to associate your name with an academic position, supporting the teaching and research activity of a high-profile professor on strategic issues of common interest. The naming may be permanent or term. The gift of a permanent naming constitutes a capital asset and contributes to ensuring the University's future and mission. A term naming covers the costs of the chosen professor for a minimum of 5 years, with the opportunity to renew the support.

► NAMED CENTERS AND RESEARCH LABORATORIES

Establishing a named research center or laboratory is a unique opportunity to give relevance and visibility to extremely topical research in areas of common interest between donor and university, actively contributing to the advancement of knowledge in a specific field. These facilities are coordinated by a high-profile professor and are characterized by an international and stimulating *research environment*, which attracts academic excellence. Moreover, in line with the Bocconi approach aimed at promoting the expansion of disciplinary areas and *knowledge integration*, Centers and Laboratories mix different skills within them and are characterized by their interdisciplinary approach.

Equita SHEDDING LIGHT ON THE NEW GEO-STRATEGIC AND ECONOMIC-FINANCIAL CONTEXT

In Italian and international geo-strategic and economic-financial contexts, characterized by extreme uncertainty and volatility, we need scientific research capable of explaining complex phenomena and trends, and interpreting and modeling them, for the benefit of capital markets and policymakers.

Since 2013, Equita and Bocconi University, via their partnership, have stimulated debate on the capital market in Italy. Through collaboration with the Baffi-Carefin Research Center, Equita produces an annual position paper, Observatory on Capital Markets in Italy, and a conference at Bocconi. There, the “Equita Award for the Best Strategy on Capital Markets” is named. In 2019, the collaboration between Equita and Bocconi took another step forward, with a new partnership focused on *Capital Markets Influential Research*, which created the Equita Lab in Capital Markets. The four-year laboratory includes Professors Stefano Caselli, Stefano Gatti, Gimede Gigante, Carlo Chiarella and Giulia Negri. It will focus on research, policy impact and dissemination on the capital market theme, analyzing structural elements and development factors, and identifying possible solutions for its growth. ■

Romeo and Enrica Invernizzi Foundation AGRI LAB, MANAGERIAL CULTURE APPLIED TO THE AGRICULTURAL SECTOR

A contribution from the Romeo and Enrica Invernizzi Foundation has created SDA Bocconi’s AGRI Lab - Romeo and Enrica Invernizzi Agribusiness Research Initiative, a research laboratory directed by Professor Vitaliano Fiorillo. The Lab will help explain the challenges within the agri-food sector and disseminate a managerial culture in the agricultural sector. It will use technological and digital tools for business development such as CoCoA, an online tool to spread the principles of management control among farms, and the MOOC “Challenges of Agribusiness Management,” a free online course on the key dynamics of the agri-food sector published on Coursera. AGRI Lab is also conducting research on innovation models and new technologies that will influence sector development. This valuable support for AGRI Lab is the most recent in a series of collaborations over 30 years aimed at progressing research and developing young researchers, and linking the Invernizzi Foundation to Bocconi University. ■

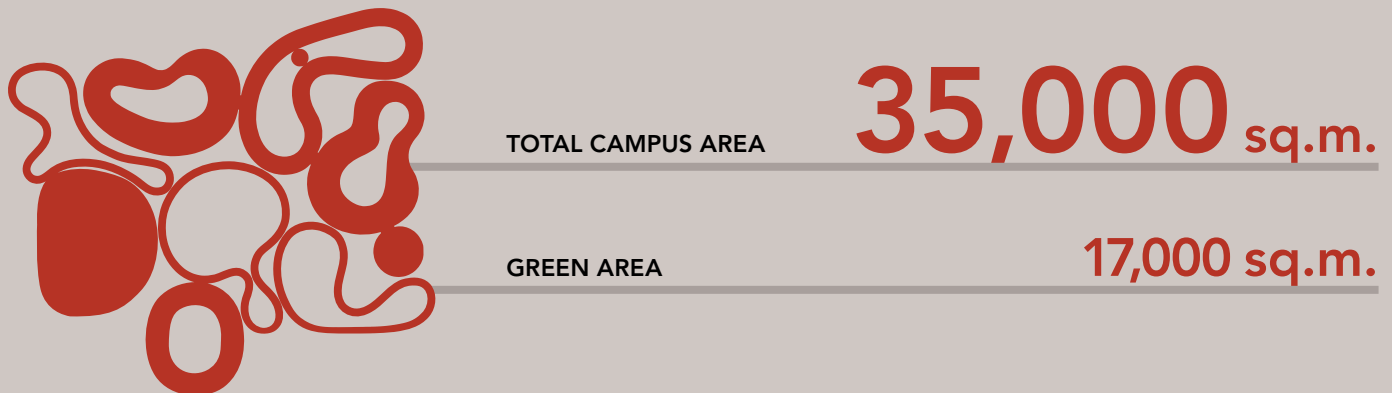
The new Campus

2019 has been a particularly significant year for Bocconi University: on November 25, in conjunction with the opening ceremony of the new academic year, the new University Campus was inaugurated with the presence of President of the Republic Sergio Mattarella.

Designed by **SANAA**, the studio of **Kazuyo Sejima and Ryue Nishizawa**, this new university campus was built on the 35,000 sq.m. site of the former Centrale del Latte site and represents a true landscape intervention for the city, an **open space for Milan** and its citizens. The soft lines, the transparency of the buildings and the 17,000 sq.m. of green space achieve the dual objective of shaping a new and organic urban campus and creating a green lung together with nearby city

parks. This space will be the **new home of the SDA Bocconi School of Management**, in addition to hosting a **300-bed residence hall** within its boundaries, as well as a multifunctional sports center with state-of-the-art equipment, which, like the park, will be open to the public.

It is also an example of cutting-edge technology, with a 360-degree learning experience and a use of space supported by the *Internet of Things* and a sophisticated **Building Management System**, which guarantee strong interactivity between the user and the structure.

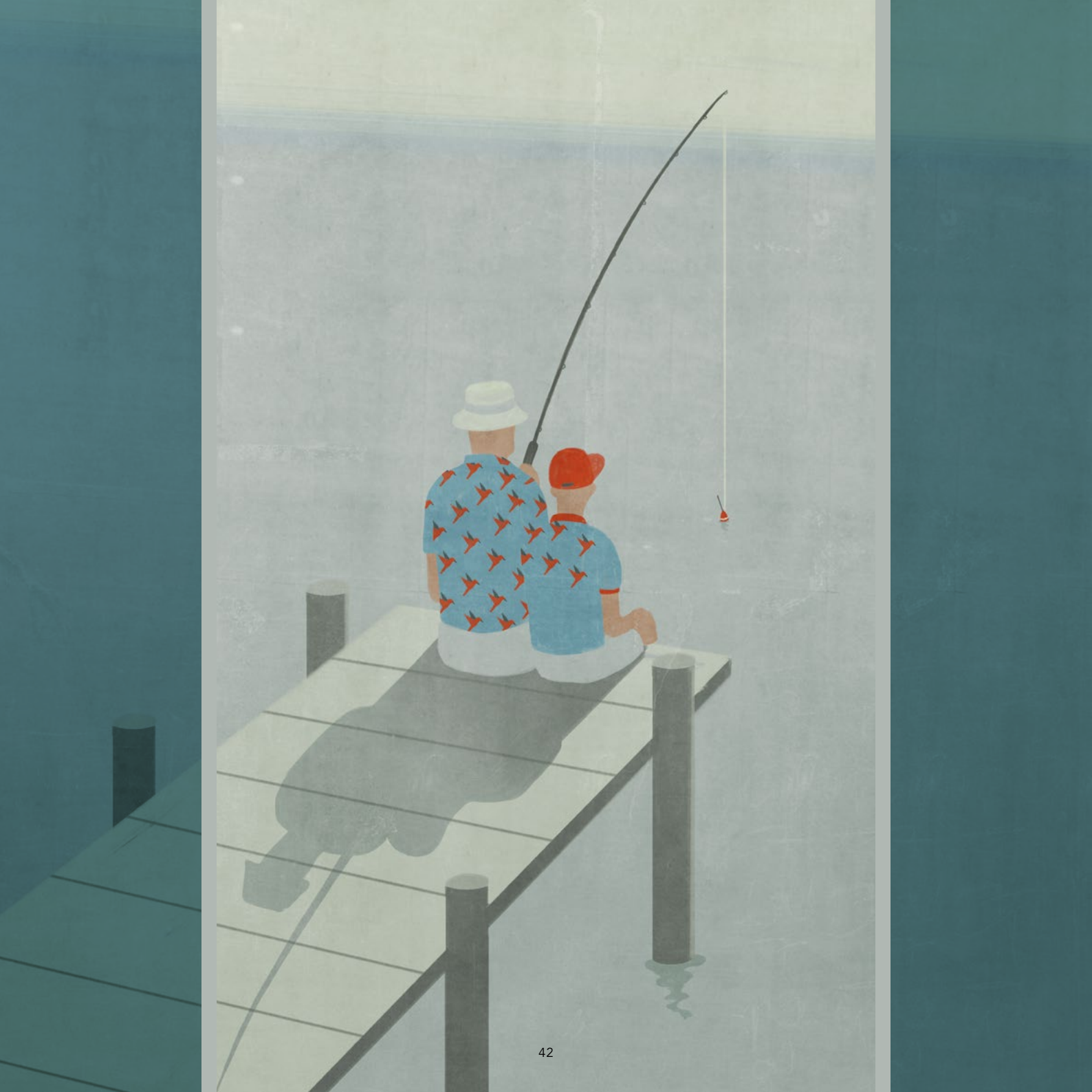

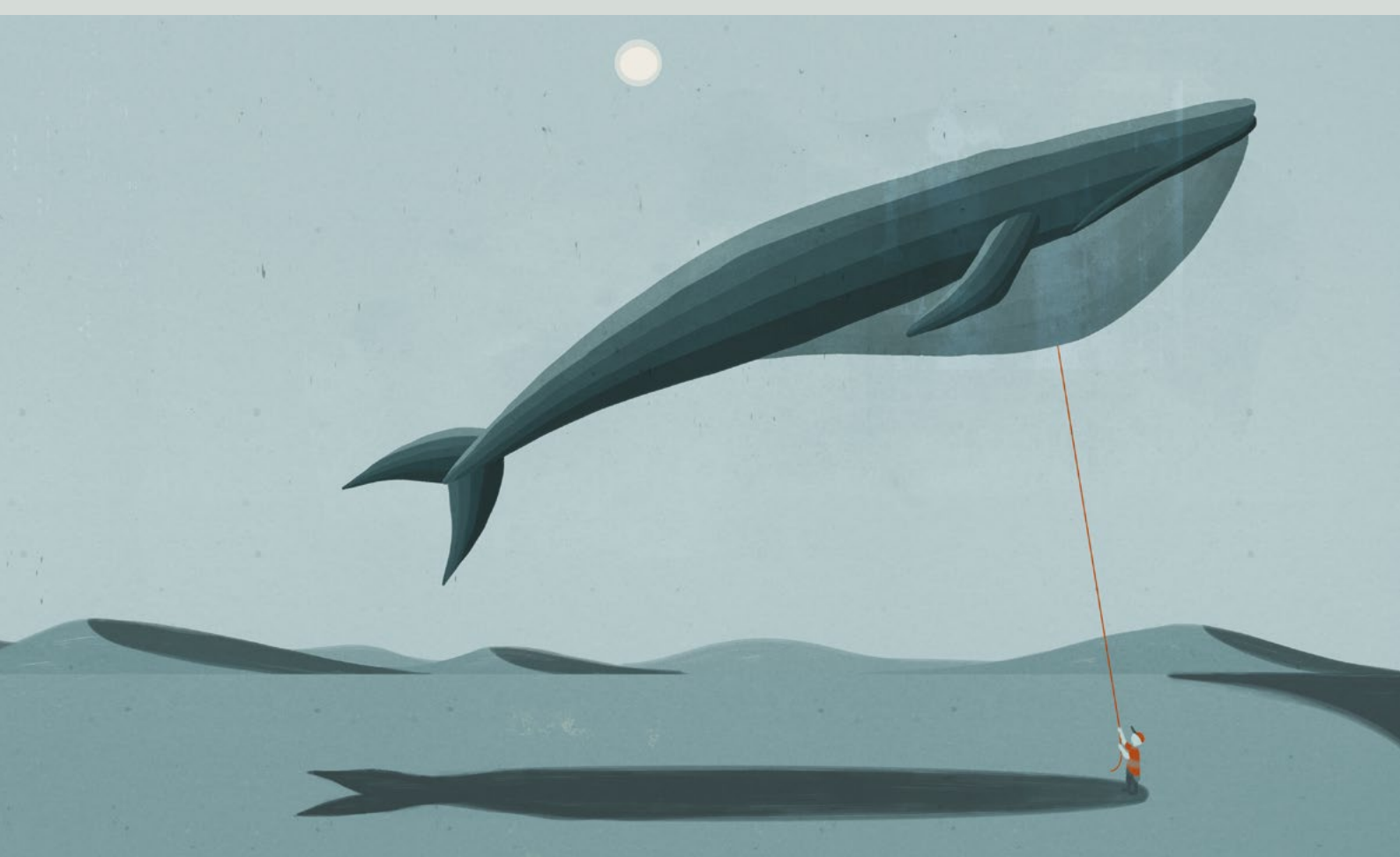

The pelican has been the University's mascot since the time of the Bocconi University Graduates Association (ALUB), which chose it as its symbol at the beginning of the last century. Blue and white are the University's colors. Pelicans have been the emblem of altruism since ancient times.

Leoni Circle

The lion sculptures, by Arturo Martini, in the entrance hall of the main building at Via Sarfatti 25, are the University's symbol par excellence. Tradition has it that you may walk between them only after graduating. Lions represent strength, prudence and courage.

Alloro Circle

from 10,000 to 49,999 euros
- ▶ **ALLORO SILVER**
from 50,000 to 99,999 euros
- ▶ **ALLORO GOLD**
over 100,000 euros
- ▶ **ALLORO DIAMOND**
over 1,000,000 euros

The laurel (alloro) wreath in the University's crest represents the accomplishment and the good fortune of having achieved knowledge and understanding through sacrifice and dedication. The laurel – laurus in Latin, from which the word "laureate" also derives – is a symbol of victory, knowledge and wisdom. For this reason, it is used to crown new graduates.

1902 - Loyalty Society

This society recognizes all donors who have supported the University for at least two consecutive years.

It commemorates the year in which Ferdinando Bocconi, by donating part of his own estate, founded Bocconi University in memory of his son Luigi.

Ettore Bocconi Society

This society comprises all donors who have made a bequest to the University. Ettore Bocconi, son of Ferdinando and brother of Luigi, led the University until his death and bequeathed the entire Bocconi family estate to the University his father had founded.

Endowment Donors

Alumni and individuals that choose to donate to the endowment, rather than to current priorities, are donors who demonstrate that they place great trust in the University, its mission and its management of resources. The endowment is, in fact, the University's capital fund, which the University invests for the long term and which generates an annual return, guaranteeing the independence and sustainability of Bocconi activities over time.

Tax Advantages

ITALIAN TAXPAYERS

INDIVIDUALS

Contributions and donations made by individuals can be deducted in full from their gross income (art. 10 comma 1 letter l-quarter of DPR 917/1986 TUIR).

CORPORATIONS

Contributions and donations are deductible for an amount not exceeding 2% of the company's declared taxable income according to art.100, comma 2, letter a) of DPR 917/1986 - RM of 17 October 2008, n. 386/E.

Contributions and donations from businesses to universities specifically in support of research are fully deductible from their declared taxable income according to art. 1, comma 353 of Legge Finanziaria 2006.

RESIDENTS OF OTHER EUROPEAN COUNTRIES

Bocconi's membership in the Transnational Giving Europe network may allow tax benefits for residents of 19 European countries.

UK TAXPAYERS

Charitable contributions of £250+ from UK taxpayers may be made through Charities Aid Foundation and may be eligible for UK tax advantages and Gift Aid.

US TAXPAYERS

Charitable contributions to the University may be made through the US non-profit corporation Friends of Bocconi University and may be eligible for US tax advantages.
