For you – our **1,300** Donors of the 2022-2023 academic year – is a message informing you of the enormous impact of your generosity. Your continuous, passionate and selfless support represents an antidote to short-term thinking and an invitation to invest in the future by spreading knowledge.

One year ago, the new rectoral mandate was published – the first for Professor Billari – which reflects and reinforces many of the values already expressed in Bocconi's 2021-2025 Strategic Plan and 2030 Vision. This Donor Report has been built from four key concepts on which these strategic documents are based: **inclusion**, **community**, **social sciences** and **sustainability**.

- Together with you, we promote inclusion with a view to being a driver of social mobility and accessibility, aware that talent – whether in study or research – can be found anywhere, while opportunities are not so omnipresent. Our system of scholarships and tuition waivers, which have increased by 17% since 2021 and are supported by many Donors, now means that more than one in four students receives some type of assistance.
- Developing the study of **social sciences** is our mission in order to find solutions to the complex problems of the modern world, adding to the other historic Bocconi disciplines linked to computer sciences, Europe and sustainability (since 2021, four new named academic positions and two Research Labs have been established).
- **Sustainability** is another priority for Bocconi, not only in managing the Campus with the decarbonization plan, but also in Research with a view to contributing to sustainable development and responding to the demand for knowledge of new generations (the Master of Science in Transformative Sustainability has been launched in partnership with some Donors).
- Finally, the Bocconi **community** is a dynamic group of people at the University who believe in intergenerational solidarity (13 fundraisers organized by groups of Alumni, in some cases also with the additional support of their companies).






NAMED SCHOLARSHIP FUNDS: CORPORATIONS AND FOUNDATIONS CONTINUOUS SUPPORT

Named Scholarship recipient

A Named Scholarship Fund is an act of faith in the future. It means strongly believing that everyone's tomorrow will be better if access to university education is more equal and shared today. By way of a Named Scholarship Fund, a Donor chooses to offer **support over the minimum timeframe of two years**, sometimes focusing on a particular category of students or a specific study area.

During the 2022-2023 academic year, Bocconi boasted over 40 recipients of the 14 Named Scholarship Funds. These 40+ young people form part of a total of **350 students on campus** who have begun or continued their education at Bocconi thanks to the support of the Donors. There were 23% more first-year students than there were in 2021.

Donor funds are added to those made available by Bocconi for a total of over **€41 million dedicated to students**. This sum enables more than one in four students to receive some type of support, partial or total.

Partners and Donors such as Amazon Prime Video, Bottega Verde, Ceresio Investors - Foglia Family, Fasanara Capital, Fondazione Permira, OTB Foundation, Istituto Javotte Bocconi Manca di Villahermosa Associazione "Amici Della Bocconi", as well as one Partner who opted to remain anonymous, decided to establish or renew a Named Scholarship Funds during 2022-2023.

AN OPPORTUNITY FOR CHANGE IN RESPONSE TO INEQUALITIES

Hafsa Nagawa, Akili Alembe Dikonzo and Lea Christine Itumu Kikorasono are three students who arrived at Bocconi thanks to the **UNICORE** - **University Corridors for Refugees** project – an initiative created by UNHCR, Caritas, Diaconia Valdese and MAECI in collaboration with Italian universities. The project offers students with refugee status the opportunity to continue their studies in Italy with full financial support.

The UNICORE and **Forced Migrant Students** projects are aimed at supporting people in conditions of particular difficulty linked to their country of origin. There are other programs dedicated to Italian students, including "**Una Scelta Possibile**" which helps to close the social gap of inequalities that exist in Italy. Thanks to the generosity of its Donors, Bocconi continues to demonstrate its commitment through tuition waivers, scholarships and activities aimed at fostering students' admission into university and improving their wellbeing during their studies.

RESEARCH LAYS THE SCIENTIFIC FOUNDATIONS FOR A MORE EQUITABLE WORLD

Studying scientifically valid mechanisms and instruments in favor of diversity, inclusion and equal opportunities: this is one of the greatest challenges of our time, one which Bocconi aims to take on together with Donors, building a more just world for all.

This is the case, for example, with the research activities of LEAP – Laboratory for Effective Anti-Poverty Policies, the Bocconi Laboratory established thanks to the generous donation of the Fondazione Romeo ed Enrica Invernizzi, which aims to understand and combat poverty through effective evaluation methods. This contribution goes towards achieving the first "No Poverty" objective of the Sustainable Development Goals of the UN 2030 Agenda.

By supporting the activities of the **CERGAS Research Centre – Centre for Research on Health and Social Care Management** of SDA Bocconi, the Partners and Donors contribute to generating a positive impact on society. **Fondazione Allianz Umana Mente** and **Fondazione Ravasi Garzanti** support, for example, projects related to integration and social policies, in the scope of disability and volunteering.

Finally, on the matter of equal opportunities, during the 2022-2023 a.y. **AXA Italia** and **AXA Research Fund** renewed their commitment to supporting the **AXA Research LAB on Gender Equality**. The Lab, established in 2020, is aimed at promoting gender equality in the economic and social spheres through rigorous scientific methodologies and the dissemination of research findings.

Fondazione Romeo ed Enrica Invernizzi Chair in Computer Science

The greatest aspiration that our Donors help us to achieve is to **advance the frontiers of knowledge to create a better society**. Attracting the finest professors and researchers from all over the world and further strengthening scientific investigation in the social sciences remains one of Bocconi's primary objectives. In this respect, Donors not only contribute to establishing new Chairs in disciplines of high impact, but also pledge to support them for a minimum duration of five years, knowing that scientific research needs medium to long-term timescales to bear fruit. Supporting a Chair or Professorship offers the Donor the possibility of agreeing on a common topic of interest, enabling the research findings to be used at the service of the community. These are often innovative fields of great impact, which lead to **cutting-edge studies of huge public interest**.

During the 2022-2023 academic year, the permanent Chair established by the **De Agostini Group** was inaugurated, known as the **De Agostini Endowed Chair in Corporate Strategy**, assigned to Professor Sonja Opper. The topics forming the subject of the research – managerial skills, diversification and internationalization – are key elements of the path undertaken by the De Agostini Group under the guidance of Marco Drago, now President Emeritus.

At the same time, the **Fondazione Romeo ed Enrica Invernizzi** – in line with its statute – confirmed its support for frontier disciplines, allowing Bocconi to establish three fixed-term Chairs: **Behavioral Economics and Finance**, assigned to Professor Nicola Gennaioli; **Computer Science**, assigned to Professor Luca Trevisan, who returned from the United States precisely to cover this role; and finally **Innovation Management**, assigned to the previous Rector Gianmario Verona. The **Generali Endowed Chair in European Policies - Shaping Leadership in Europe** was also established during the same academic year, assigned to Professor Catherine De Vries.



DISCOVER THE NAMED CHAIRS AND PROFESSORSHIP It is an ambitious approach to support a new Research endeavor that will evolve over the years with activities that are not yet entirely predictable. I hope that this way of supporting Research, focused on the long-term and not on the immediate result, becomes common and that the example of Fondazione Invernizzi is replicated as often as possible.

POWERHOUSES OF KNOWLEDGE AND DISSEMINATION: THE WORK OF THE LABS

Director of the AXA Research Lab on Gender Equality and Dean for Diversity, Inclusion and Sustainability

The Research Laboratories gather together a pool of professors, coordinated by a director, who cover different fields to guarantee a multidisciplinary approach, in which the different areas of expertise are consolidated, thereby encouraging **knowledge integration**. The goal is to respond to the Research interests of the Donor, thanks to the prominent members of the faculty.

The added value of this type of research is in its **involvement of various departments**, which gives life to an intellectually stimulating study group, engaged and open on all fronts – often leading to significant results. The **collaboration with researchers from leading universities** including Harvard and Oxford, as well as the involvement of highly talented, dedicated young people who study or work at Bocconi, give rise to these fully-fledged hotbeds of ideas. Supporting a Research Lab may also consist of drafting scientific documents and organizing **dissemination** events, in order to present the research findings to particular stakeholders or the general public.

The mission of the new **Management Science Lab**, established in 2022 with the **ION Foundation** and directed by Professors Arnaldo Camuffo and Alfonso Gambardella, is to produce high-impact management science research, allowing companies and research institutions to advance the frontier of knowledge. The **Fintech Lab** began operating during the same year, in partnership with the blockchain platform **Algorand**. Under the direction of Professor Claudio Tebaldi, the Lab aims to study the evolution of digital financial services and their regulation in order to promote the most advantageous financial applications for society.





THE NEW INSTITUTE FOR POLICYMAKING

Director of the Institute for European Policymaking @ Bocconi University

Bocconi's European and pro-European spirit is reflected in all its activities and is shared with its community of Alumni and Donors – Italian and international. From the institution of the Fondazione Achille e Giulia Boroli Chair in European Studies and BLEST–Bocconi Lab for European Studies, to the participation in the CIVICA network of European universities – just to name a few of the initiatives – Bocconi aims to not only actively participate in the debate on European issues, but foster sharing and consensus around the values of Europe and the European project as well. The **Institute for European Policymaking @ Bocconi University (IEP@BU)** was founded in this context.

Established by Bocconi University and the Istituto Javotte Bocconi as a sign of gratitude and esteem towards Mario Monti, who is its honorary president, IEP@BU is strongly characterized by **interdisciplinarity**. It combines the analytical rigor of a **research centre** with the ability of a **think tank** to influence policymaking processes, with particular attention to **communication and dissemination** activities towards the public. Under the direction of Daniel Gros along with President Guido Tabellini and a Management Council of the highest academic profile, the Institute aims to implement, discuss and disseminate high quality research on the main policy matters addressed by the European Union and its Member States in a rapidly changing world, contributing to improving policymaking processes.

RAISING CHANGEMAKERS: TRAINING IN SUSTAINABILITY

Named Scholarship recipient

A fundamental challenge and responsibility for Bocconi is to **inspire the future key players of sustainable change, through education and teaching**.

During the 2022-2023 academic year, the **Master of Science in Transformative Sustainability** was launched, a Double Degree developed **in collaboration with Politecnico di Milano**. It is a program that offers an integrated and innovative perspective on sustainability, ranging from technical fields related to sustainability (technologies for the environment, energy, mobility and circularity) to fields in the social sciences (management, economics and quantitative and legal disciplines) – required to manage a sustainable and just transition.

As part of this Master of Science, collaborations have been launched with two major Partners: **Fondazione Pesenti** and **Kering**, which have committed over several years to cover total and partial tuition waivers for students enrolled in the program, demonstrating particular attention both to sustainability and the importance of accessible education.

The MSc was established in the wake of historical attention to these disciplines at Bocconi. Since 2015 the **MASEM - Master in Sustainability and Energy Management**, equally supported by numerous Partners and Donors, has been recognized as one of the world's best Master degree programs in this area.



STUDYING SUSTAINABLE SOLUTIONS FOR THE PLANET: FROM URBAN SYSTEMS TO AGRICULTURE

Director of GREEN - Centre for research in Geography, Resources, Environment, Energy and Networks

Pooling forces to **seek solutions and tools for sustainable change** is the challenge taken up by Bocconi and shared with all those Donors who, over the years, have increasingly generously supported research on topics of sustainable development and just transition.

The **GREEN** - **Centre for Research on Geography, Resources, Environment, Energy & Networks** has been active since 2018, with its activities and research projects being supported by strategic Donors such as **Fondazione Romeo ed Enrica Invernizzi**. In 2022 the Centre continued its studies in very topical areas such as the green economy, renewable energies and interconnections between sustainable development and the climate crisis.

As part of the Centre's activities, in 2020, the **SUR Lab – Sustainable Urban Regeneration Lab** was also established thanks to the generosity and contribution of four major Partners and Donors - **Hines**, **Intesa Sanpaolo, MilanoSesto** and **Prelios**. The Lab aims to develop and disseminate knowledge, methods and best practices on sustainable urban regeneration processes and how they generate value for the private sector and society. The Lab's important collaborations include its work with the United Nations Human Settlements Programme (UN-Habitat).

Furthermore, the **Agri Lab Romeo ed Enrica Invernizzi Agribusiness Research Initiative** has been historically active in research on the border between agribusiness, technology and sustainability. In 2022, in particular, the research team investigated topics of food security related to the climate crisis and the contribution of the agro-industrial sector to achieving climate neutrality goals, through initiatives for atmospheric carbon storage in the soil (carbon farming).



A CAMPUS THAT EVOLVES SUSTAINABLY

Alumnus and Donor

The Bocconi Campus is home to a vivacious and constantly growing community, open to the city and to cultural fusion. The challenge we pursue, with the support of our Donors, is to **regularly expand and upgrade the spaces of the University**, rendering them increasingly accessible and sustainable. In fact, the University is not just a place of teaching, but a **space to live**, **share and exchange** – enriched by spaces for leisure, where the Bocconi community grows side by side with the countless student, sports and social associations, along with rich cultural initiatives.

On one hand, Bocconi strives to expand the spaces starting with the investment in the new Campus and its facilities, and, on the other, its challenge is to take forward the ambitious decarbonization plan. This plan foresees achieving carbon neutrality by 2025, only then to focus on the Net Zero goal, including all the other main indirect emissions. In addition to this, the University's certification process has commenced to calculate its carbon footprint according to the ISO 14064-1 standard, which will conclude by 2023.

The Bocconi Campus, consisting of both the historic and newly constructed buildings, has benefited over the years from various donations from individuals, companies and foundations, rendering sustainable development and evolution possible. For example, the 2022-2023 academic year saw the opening of Room C.E2.06 at the new SDA Bocconi School of Management, dedicated to the 2002 Alumus of the Year Marco Drago – thanks to the philanthropic gesture of the De Agostini Group, of which Drago is now President Emeritus. In addition, a new Alumni Space open to the Community will soon be inaugurated on the new Campus, and inside will be remembered the names of Alumni and Donors who have been willing to give their support so that our University can be increasingly open and welcoming.

There are currently 49 named spaces on Campus.

MEMORIAL FUNDRAISING CAMPAIGN: AN ENDURING LEGACY

Professor **Francesco Daveri**, Director of the MBA at SDA Bocconi School of Management, lived by teaching the "sense of what is possible". His favorite saying to students, colleagues, friends and relatives was "Don't worry, we'll find the solution". It is no coincidence that he was known as "the smiling economist" even among the editorial staff of the newspaper Corriere della Sera, with which he worked. His premature death in 2021 left an enormous void in all the lives that he had touched. His legacy will remain forever linked to his Alma Mater thanks to the fundraising campaign in his memory, organized by relatives, friends and colleagues – a campaign which funded a tuition waiver for his MBA program (in the previous year, SDA Bocconi had established another scholarship in his memory).

On the other hand, finance manager and philanthropist **Andrea Potsios** did not study at Bocconi, but after his premature death in 2021, his wife Veronica Artioli Potsios wanted to honor his memory through the University. Thanks to a memorial fundraising campaign that was organized with a charity auction, a study hall in the Library – right in front of the shelves containing the finance books – was named after Andrea Potsios and a tuition waiver was also established in favor of a student passionate about the same subject.

A **memorial fundraising campaign** helps remember those who stood out in life and became bearers of the values of the Bocconi community throughout the world. It is an opportunity to sow a seed for the future, transforming a void into an opportunity for new generations.

OUR DONORS ALUMNI AND INDIVIDUALS

Bocconi University is grateful to all individuals and Alumni who have chosen to support its initiatives. Donors are included in **Giving Societies**, categorized based upon the value of the donation.

The major donors belong to the **ALLORO CIRCLE** (sacred plant for the Greeks and Romans, and symbol of knowledge and glory), which is split into:

- ALLORO DIAMOND for those donating over €1,000,000
- ALLORO GOLD for those donating between €100,000 and €999,999
- **ALLORO SILVER** for those donating **between €50,000 and €99,999**
- ALLORO BRONZE for those donating between €10,000 and €49,999

All **Alumni and individuals who donate up to €9,999** are grouped, on the other hand, into the following categories:

LEONI CIRCLE (for donations between €1,000 and €9,999)

The lions at the campus entrance on Via Sarfatti 25, designed by Arturo Martini, are the very symbol of the University. Tradition has it that it is only possible to pass through them after having graduated. The lion is the symbol of strength, prudence and courage.

■ PELLICANI CIRCLE (for donations up to €900)

The pelican has been the University's mascot since the times of the Associazione Laureati Università Bocconi (ALUB), which chose it as its symbol at the beginning of the last century. The blue and white, on the other hand, represent the colors of the University. Since ancient times, the pelican has been the emblem of altruism.

ENDOWMENT DONORS

Alumni and individuals that choose to donate to the endowment, rather than to current priorities, are donors who demonstrate that they place great trust in the University, its mission and its management of resources. The endowment is, in fact, the University's capital fund, which the University invests for the long term and which generates an annual return, guaranteeing the independence and sustainability of Bocconi activities over time.

ETTORE BOCCONI SOCIETY

This society comprises all donors who have made a bequest to the University. Ettore Bocconi, son of Ferdinando and brother of Luigi, led the University until his death and bequeathed the entire Bocconi family estate to the University his father had founded.

1902 - LOYALTY SOCIETY

This society recognizes all donors who have supported the University for at least two consecutive years. It commemorates the year in which Ferdinando Bocconi, by donating part of his own estate, founded Bocconi University in memory of his son Luigi.
